

Oyster River School Board Minutes
Wednesday, 8 June 2011

School Board workshop – Goals setting

Present: Henry Brackett, Ann Wright, Krista Butts, Jim Kach, Ann Lane, Megan Turnbull, Jocelyn O'Quinn.

Also Present: Sue Caswell, Danielle Bolduc, Meredith Nadeau, Todd Allen, Krista Butts, and numerous members of the community.

Ann Wright called the meeting to order at 7:15 PM.

Motion by Krista Butts, seconded by Jim Kach, to enter non-public session under RSA 91-A:3 II (b). This motion passed by roll call vote 5 Aye – 0 Nay. (H. Brackett and A. Lane arrived at 7:20 PM)

Non-public Session –

Superintendent Howard Colter nominated Mr. Todd Allen to serve as interim principal for Oyster River High School, effective 1 July 2011 through 30 June 2012, with an annual salary of \$96,500.

Motion by Krista Butts, seconded by Ann Lane, to elect Mr. Todd Allen interim high school principal. This motion passed by unanimous a vote (7 Aye – 0 Nay.)

The school board adjourned non-public session at approximately 7:30 PM. and re-entered public session.

Motion by Krista Butts, seconded by Jim Kach to re-enter public session at 7:35 PM. This motion passed by roll call vote 7 Aye to 0 Nay.

Henry Brackett announced that Todd Allen was elected to serve as high school principal for the coming year. Mr. Allen received a round of applause and hand shakes of congratulations.

Henry Brackett shared copies of a draft press release announcing Mr. Allens appointment. After discussion and amendments to the draft statement the school board approved a press release.

Motion by Krista Butts, seconded by Megan Turnbull to approve a press release, as amended. This motion passed by unanimous vote (7 Aye – 0 Nay)

The school board reviewed current school board goals and discussed limiting them to a few broad, overarching goals in the future. Educational philosophy, key performance indicators, and developing a “realistic budgets that meet the school district’s educational needs”, were three ideas for future goals that received considerable discussion. The school board agreed to continue this discussion on 15 June 2011.

Henry Brackett set another workshop for Wednesday, 22 June 2011, at the SAU, to discuss budget goals for Fiscal Year 2013. The meeting is scheduled to run from 7:00 to 9:00 PM.

Motion by Jim Kach, seconded by Krista Butts, to adjourn the meeting at 9:20 PM. This motion passed by unanimous voted (7 Aye – 0 Nay)
