Dear members of the ORCSD Board,

I am writing to protest against the decision of the Board to select a superintendent without site visits and additional due diligence. As a member of the superintendent selection committee, I know the committee reviewed application materials and interviewed candidates, but did not conduct due diligence beyond the recommendation letters included in the applications. Because of these limited data, our task was merely to recommend candidates for further due diligence and consideration. We believed each candidate had strengths that merited further consideration. Through our process, we also shared questions/concerns about each candidate that could not be resolved through our interviews — or solely through candidate visits to ORCSD.

The Board should commit the time and resources in the next 1-2 weeks to visit each candidate's community and speak with stakeholders about their effectiveness and leadership style. We need these additional data to make an informed decision on whether any of these three candidates are a strong fit for Oyster River's needs. We also should go through this process in order to satisfy all stakeholders. If we think one of these candidates could do an excellent job after further vetting, let's bring him on board quickly in permanent capacity and begin to move forward as a community. However, just as it would be negligent to delay an offer to an excellent candidate due to political reasons, it is equally negligent to extend an offer without site visits and adequate due diligence.

Screening Committee announced the three finalists recommended for our District's permanent Superintendent position. After one and a half weeks of going through applications and one round of interviews, the Screening Committee narrowed a pool of 15 completed applicants down to Dr. John Bacon, Mr. Jay McIntyre and Dr. James Morse; Bios may be found here.

In past searches, it has been customary to set up site visits to each candidate's school district. However, in a change from the posted search calendar which had included site visits and telephoning, the School Board has chosen not to take these important steps.

On Tuesday and Wednesday, January 24th and 25th, the candidates will visit ORCSD to meet our administrators, staff, parents and students. All community members are invited to attend the public forums:

- Tue., Jan. 24 at 5:15 pm at the High School Library with Mr. Jay McIntire
- Wed., Jan. 25 at 5:15 pm at the High School Library with Dr. James Morse
- Wed., Jan. 25 at 6:15 pm at the High School Library with Dr. John Bacon

We will have a chance to ask questions and provide feedback to the School Board on a feedback form. The School Board will conduct a public interview of each candidate after the forums. A final decision which was scheduled to be made on Feb 6th, is currently posted and scheduled to be made on Thursday, January 26th. It is critical to attend and providing input at these forums to ensure the School Board chooses a candidate that is the right fit for our community.

Public Budget Hearing Update

On January 17 the Oyster River School Board held a public hearing on the proposed budget. Click here for a copy of the budget presentation. Residents had an opportunity to pose questions on the budget and offer comments. Residents expressed appreciation for the time and effort involved in preparing the budget, and for keeping the taxpayers in mind. Other residents questioned the process that resulted in last minute, ad-hoc cuts that were not recommended by the superintendent. There were many comments against the proposed cuts, particularly the elimination of the assistant principal and .5 math teacher at the high school. The School Board did not answer individual questions, but board member O'Quinn provided some initial responses, and said all questions would be

School Board Finalizes 2012-2013 Proposed Budget

At the January 18 School Board meeting, the board voted to approve a budget to be presented to the voters at the deliberative session. Superintendent Levesque initially proposed a budget to the board with a .6% increase over last year's budget, however the board made additional reductions totaling \$387,679. These proposed reductions include an assistant principal at the high school, a .5 math teacher at the high school, a district data manager, and funds to purchase 50 replacement computers in the district.

Community members will have the opportunity to amend the school board budget at the deliberative session on February 7 at 7:00 at the high school (snow date February 8). The final version of the budget will then appear on the ballot March 13.

Permanent High School Principal

_ Congratulations to Todd Allen who was approved as principal of ORHS at the School Board's meeting on January 18. The nomination was met with a resounding round of applause. Mr. Allen has been serving as principal on an interim basis since Laura Rogers' resignation in June 2011. Prior to that he served as ORMS assistant principal, and spent many years teaching social studies at ORMS. Good luck Mr. Allen!

School Board Member Ann Wright Resigns

School Board member Ann Wright announced her resignation from the Board effective January 24. Ann was recognized by fellow board members and by residents during public comments for her hard work, unique perspective, and her deep commitment to education and the children of the district. A new at-large board member will be elected in March to fill the remaining year of her term. The board will consider whether to appoint someone to fill her seat until the election. Several Community members suggested appointing Ann to serve until the election.

Ruling in the Right to Know Lawsult

On January 17, the Strafford County Superior Court issued a notice of decision on Durham resident David Taylor's lawsuit against the Oyster River School Board and Henry Brackett, Chairman. The ruling upholds Mr. Taylor's assertion that the ORCSD school board violated the Right-To-Know (RTK) law on multiple occasions during the period of time when the former superintendent's contract was being bought out and the hiring of an interim superintendent. The judge granted Mr. Taylor's request for documents and redacted information under RSA 91:A. The court cited the following factors in awarding payment of Mr. Taylor's legal fees: He was denied access to documents after making reasonable requests for information; the lawsuit was necessary to make proceedings open to the public; and the board knew or should have known that they were violating the RTK laws. The court did not enjoin the board from making any future violations because the board has already indicated its willingness to comply. For a copy of the complete ruling click here.
